

Safety Shower Inspection, Test & Maintenance Service



Just because you bought a compliant safety shower and eye wash it is not the end of your responsibility. In order for your safety shower to remain compliant, a scheduled maintenance system must be in place.

AS4775 is the Australian Standard for Safety Shower and Eye Wash Equipment. In addition to the regular operational testing the must be undertaken the equipment must have an annual inspection to all aspects of compliant operation are maintained. The Standard states:

“All shower units shall be inspected annually to ensure conformance with the requirements of this Standard. A tag should be permanently attached to each shower unit, to be marked at the successful completion of each inspection.”



Poorly maintained emergency eyewash and shower equipment could lead to life changing injuries to an employee. Chemical and other splashes and spills can seriously maim and disfigure your workers. Emergency eyewash and shower equipment provide a speedy first line of defence to help reduce injury.
